Freight: F.O.B. our warehouse

Terms: 1/3 down payment to start order. Balance including freight is due prior to shipping check, money order, cashier's check or wire instructions can be provided for payment. Credit card cannot be accepted at this time.

Returns: No product or parts can be returned for credit unless written authorization by Equine Equipped, LLC is given in advance.

Sales Tax: Prices do not include applicable taxes or duties. Buyer is solely responsible for paying all applicable taxes and duties. Equine Equipped LLC will add sales taxes to the sales price where required by applicable law, and Buyer will pay such taxes unless Buyer provides Equine Equipped LLC with a duly executed sales tax exemption certificate.

Damages: Equine Equipped, LLC is not liable for damage or loss of merchandise once it has shortages in left our warehouse. Purchaser is solely responsible for filing claims against the carrier shipment and for any loss or damage upon receipt of merchandise. We will make a reasonable attempt to assist you in securing an adjustment for any loss or damage, provided you have filed with the carrier. Claims for shortages in shipment must be made within 10 days of receipt of goods.

Warranty: Equine Equipped, LLC warrants the Stable Boy® Horse Stall Conversion Kit for a period of one year from the date of original purchase by the original Buyer against defects in material or workmanship or both, when used in the garage of a 5th wheel toy hauler. This limited warranty applies only to the original buyer. Equine Equipped, LLC, or its authorized dealer will repair or replace, free of charge, any part or parts of the Stable Boy® Horse Stall Conversion kit, not the toy hauler, that are defective in material, workmanship, or both. The defective part or parts must be returned by the buyer to Equine Equipped, LLC or an authorized Service Dealer. All transportation charges involved in returning the part or parts to Equine Equipped, LLC or an authorized service dealer will be borne solely by the Buyer.

There are no other express warranties. Equine equipped, llc and its authorized service dealers hereby expressly disclaim implied warranties of merchantability and fitness or particular purpose, and non-infringement. Equine equipped, llc and its authorized service dealers are not liable for indirect, incidental, or consequential damages in connection with the use of the stable boy® horse stall conversion kit covered by this warranty, including any cost or expense of providing substitute equipment or repair service, except as expressly set forth herein. All warranties are excluded to the extent exclusion is permitted by law.
